# Authorization of INSB Class by Flag States

Status as of February 2023

INSB Class is recognized as a Classification Society by an extensive number of Governments (Flag States).

Authorization has been delegated for the performance of statutory functions, such as ship surveys, approvals and certification services by the Governments of the Countries listed next page.

The table indicates a summary of the main authorizations only. For countries not listed or surveys and certificates not indicated, Flag States may on special request issue the necessary authorization. The below list generally summarizes the key authorizations delegated to INSB Class and is non-exhaustive. Additional authorization applications are in process.

Full Term Statutory Certificates are issued by INSB Class Head Office exclusively, unless there is a certain Government requirement where full term certificates are issued by the country itself.

Whenever applicable – for IMO instruments entering into force- INSB Class shall issue a Statement of Compliance until Flag State(s) have accessed to the particular IMO instrument(s).
